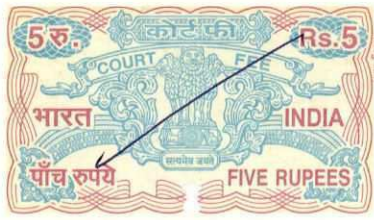

MOST RESPECTFULLY SHEWETH:-

1. That the petitioner has earlier filed the WP(c) No-15999/2024 for a direction to the opp. Party Bank specially the opp. No-1 to refund the excess residual amount to the petitioner with interest from the date of physical possession of the mortgaged property i.e. from 21.12.2015 till recovery within a stipulated period.
2. That after hearing from both the sides this Hon'ble Court directed the petitioner filed an application enclosing the original legal heir certificate before the opp. Party bank and the opp. Party after receiving the same and verify the correctness of the said legal heir certificate and accordingly ask the petitioner and other legal heirs to remain present in the bank on the date and time as convenient to them and do the needful in the matter of refund of the excess amount in accordance with law. The exercise be completed within a period of Six weeks from the date of receipt of the application as above. The copy of the order dtd.10.07.2024 passed by this Hon'ble Court in WP(c) No-15999/2024 is annexed here with as **Annexure-1.**
3. That thereafter the petitioner visited the bank submitted an application on 18.07.2024 with death and legal heir certificate of B. Subramanyam Achari along with certified copy of the order dtd.10.07.2024 in WP(c) No-15999/2024 passed by this Hon'ble Court. The photocopy of the application along with death, legal heir and order passed by this Hon'ble Court annexed here with as **Annexure-2 Series.**
4. That thereafter after receipt of the annexure-2, the bank authority sent a letter to the petitioner on 12.08.2024, which has been sent



through by post on 17.08.2024 and the same has been received on 19.08.2024 requested him to do needful in the matter as advised by the Hon'ble High Court to refund the excess amount. The photocopy of the letter dtd.12.08.2024 is annexed here with as **Annexure-3.**

5. That after receipt the annexure-3 on dtd.19.08.2024 except Vijaya Laxmi, who is the elder sister of other brothers is bed ridden due to her old age and unable to co-operate her other brothers, therefore the petitioner along with his other three brothers visited the bank on 22.08.2024 and as per the advice of the opp. Parties the petitioner along with his other three brothers submitted an application on 22.08.2024 along with details of claimants, Aadhar, PAN and copy of the Bank Pass Book. The photocopy of the application dtd.22.08.2024 along with details of claimant annexed here with as **Annexure-4 Series.**
6. That thereafter the opp. Parties directed the petitioner and his other three brothers to submit an indemnity bond, affidavit and open a new account in their bank to refund their share excess amount in their individual account. Accordingly the petitioner along with his other three brothers complied the same on 23.08.2024. The photocopy of the new account of UCO Bank, along with indemnity bond and affidavit are annexed here with as **Annexure-5 Series.**
7. That it is apt to mention here that the petitioner along with his other three brothers complied all the formalities as per the direction of the opp. Parties, but till today the opp. Parties have not refund their share excess residual amount in their individual account violating the order passed by this Hon'ble Court although

in the meantime more than three months have already been elapsed. Furthermore the order of this Hon'ble Court has not yet been complied with which established the willful and deliberate violation of this Hon'ble Court order dtd.10.07.2024, for which the opp. Parties are liable for contempt of Courts Act. Therefore this Hon'ble Court be pleased to issue appropriate direction for violation of the order of this Hon'ble Court with further direction to the said contemnors to comply the order of this Hon'ble Court as directed forthwith.

PRAYER

It is therefore prayed that this Hon'ble Court may graciously be pleased to admit this application and call for the records and issue notice to show cause as to why, the said Contemnors/Opp. Parties shall not be punished for their deliberate and willful violation of the direction of this Hon'ble Court dtd.10.07.2024 in WP(c) No-15999/2024 and if the said Contemnors/Opp. Parties failed file proper show cause and show insufficient cause, this Hon'ble Court be pleased to pass appropriate order in directing for prosecution of the said Contemnors/Opp. Parties as per the provisions of the Contempt's of Court Act, 1971, r/w Article-215 of the Constitution of India & further be pleased to pass such other order/orders as this Hon'ble Court may deem fit and proper in the facts and circumstances of the present case.

And for this act of kindness the petitioner as in duty bound shall ever pray.

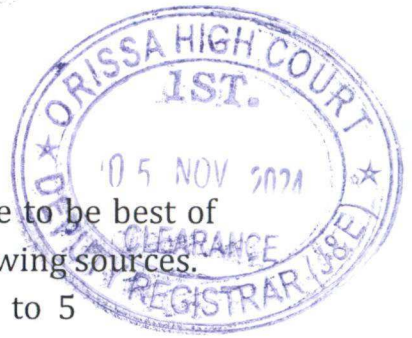

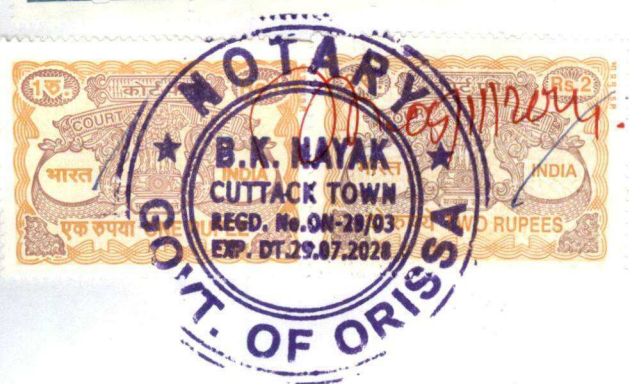

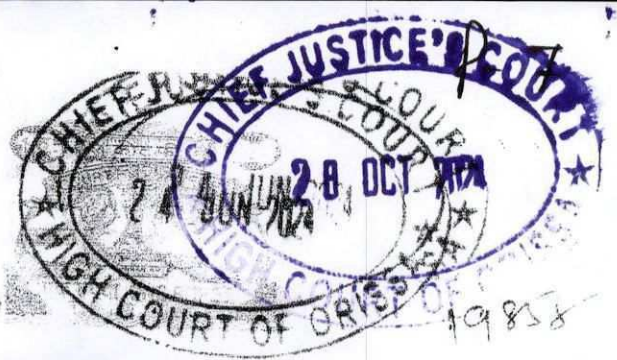

01. 1. This matter is taken up through hybrid arrangement (virtual/physical) mode.

2. The Petitioner, by filing this writ petition, has prayed for a direction to the Opposite Party No.1-Bank to refund the excess amount remaining in their hands after appropriation of the sale proceeds of the secured assets towards the loan dues, with interest.

3. Learned counsel for the Petitioner submits that this Petitioner and one of his brothers were the principal borrowers and their father was the guarantor, who had mortgaged his property for smooth repayment of the loan taken from the Opposite Party No.1-Bank. He submits that after the sale of the

mortgaged property, some amount has remained in the hands of the Opposite Party No.1- Bank after appropriation of the loan dues and that is not being refunded to the Petitioner and his co-sharers, who have inherited the property of late B. Subramanyam Achari, the guarantor. He also submits that on some occasions, all the legal heirs having even gone to the Bank premises, they had to return for non-cooperation of the Officers of the Opposite Party-Bank.

4. Learned counsel for the Opposite Party-Bank submits that the Opposite Party No.1-Bank has no intention to cause any harassment to the Petitioner and others by not refunding the excess amount and that would be evident from the fact that the amount has been very much kept in fixed deposit which is accumulating with interest. He, however submits that if the Petitioner would now be filing an application afresh with the legal heir certificate in original, the Opposite Party-Bank on receiving the same would verify all details and give the date and time for appearance of all the legal heirs of the deceased-mortgager for refunding the amount to them either in their joint account or proportionately as per their shares separately in their individual accounts.

5. Considering the submissions made, we dispose of this writ petition with the observation that in the event the Petitioner files an application enclosing the original legal heir certificate, the Opposite Party-Bank would do well to verify the correctness of the said legal heir certificate and accordingly ask the Petitioner and other legal heirs to remain present in the Bank on the date and time as convenient to them and do the

I, B.V. Ashok Achari, aged about 66 years, son of late B. Subramanyam Achari, residence of Signature Arcade, Qr. No-D/3, Bhotapada, Mancheswar, Ps-Rasulgarh, Bhubaneswar, Dist-Khurda-751017 begs to state the following few lines for your kind consideration and favourable steps.

1. That, I myself along with my other brother had a partnership firm namely M/s Sakti Sai Engine Rebuilders deals with overhauling of engines of two wheeler, three and four wheeler, DG set and marine engine. We approached your bank for sanction of term loan of Rs.15,00,000/- for business purpose on 03.07.2004. After examining the feasibility of the said proposal your bank sanctioned term loan of Rs.15,00,000/- interest @ 13.5% P.A. with monthly rest on 25.09.2004 in our favour.

2. That after availing loan the partners of the M/s Sakti Sai Engine

Rebuilders operated the loan account regularly but after death of the

guarantor B. Subhramanyam Achari and also due to down fall in the market our business became running slow, for which the loan account became irregular in operating the same. Thereafter the above loan account became NPA on 31.07.2009. Thereafter your good officials issued a demand notice under section 13(2) of SARFAESI Act 2002 demanding a sum of Rs.8,76,663.76/-(Rupees Eight Lakhs Seventy Six thousand Six Hundred Sixty Three and Seventy Six Paise Only) and thereafter issued notice under section 13(4) of the SARFAESI Act 2002 to the partners of the M/s Sakti Sai Engine Rebuilders.

3. That ultimately the mortgaged property which was recorded in the name of B. Subhramanyam Achari situated at Mouza-Raghunathpalli, in the Rourkela Town, Unit No-42 in the district of Sundargarh of Khata No-90, Plot No-93/388, area A0.060 dec. was taken physical possession by the Bank officials on 21.12.2015 evicted the legal heirs/partners including myself of the above recorded tenant forcibly.
4. That after taking physical possession on 21.12.2015 by your Bank officials, the mortgaged property was auctioned/sale on 23.03.2017 to the auction purchaser and thereafter physical possession was delivered to the auction purchaser. I along with my other brothers and sister approached many times your bank officials to refund the excess

residual amount to us. But your bank officials have never paid the excess amount to us after repeated request. So finding no other alternative I have filed WP(C) No-15999/2024 before the Hon'ble High Court for a direction to your bank officials to refund the excess amount to us and the Hon'ble High Court on 10.07.2024 directed your bank officials to refund the excess amount with interest to us within a period of Six weeks from the date of received of this application.

5. That for the interest of justice and equity I request your bank officials to refund the excess amount to me as per the direction of the Hon'ble High Court in the above Writ Application. The certified copy of the order dtd.10.07.2024 in WP(C) No-15999/2024 along with death certificate and original legal heir certificate of B. Subramanyam Achari attached here with for your ready reference.

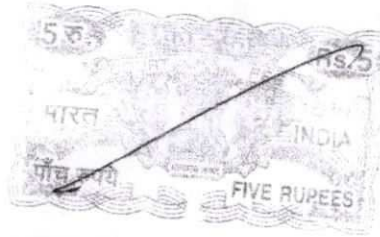

01. 1. This matter is taken up through hybrid arrangement (virtual/physical) mode.
2. The Petitioner, by filing this writ petition, has prayed for a direction to the Opposite Party No.1-Bank to refund the excess amount remaining in their hands after appropriation of the sale proceeds of the secured assets towards the loan dues, with interest.
3. Learned counsel for the Petitioner submits that this Petitioner and one of his brothers were the principal borrowers and their father was the guarantor, who had mortgaged his property for smooth repayment of the loan taken from the Opposite Party No.1-Bank. He submits that after the sale of the

mortgaged property, some amount has remained in the hands of the Opposite Party No.1- Bank after appropriation of the loan dues and that is not being refunded to the Petitioner and his co-sharers, who have inherited the property of late B. Subramanyam Achari, the guarantor. 4.
