

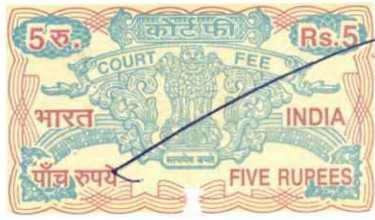



1. That, in the above writ petition, the petitioner challenges the inaction of the Opp.parties, regarding issuance of final MBA Certificate in favour of the petitioner.
2. That the petitioner is a Citizen of India, resides within the territorial jurisdiction of this Hon'ble Court and the cause of action for filing of this writ application is also arises within the said jurisdiction of this Hon'ble Court. and living within the territorial jurisdiction of this Hon'ble Court.
3. That, the facts of the case is that the petitioner was admitted in two years MBA course (Master of Business

Administration) before the Opp.party No.3 from 2016 and continued as a student of Opp.party No.3 Dr. Ambedkar Memorial Institute of Information Technology and Management Science, Rourkela. Accordingly the Opp.party No.2 registered the name of the petitioner bearing No. 1606263014 and issued Registration Card in favour of the petitioner for the Session September 2016 to September 2018. True copy of the registration certificate is filed herewith as Annexure-1.


4. That, it is humbly submitted that after admission in two years course of Master of Business Administration (MBA) before Opp.party No.3, the petitioner appeared  Semester examination from 1 to 4 and passed successfully. The mark sheet was issued by Opp.party No.2 in favour of the petitioner. True copy of the mark sheet issued by Opp.party No.1 is attached herewith as Annexure-2.

5. That, thereafter the petitioner filed application for issuance of Final MBA Certificate before Opp.party No.2

on 01.10.2019 through Gmail. But the Opp.party No.2 did not issue the final MBA Certificate. Then the petitioner approached it to the Opp.party No.3 again and again. But the Opp.parties are not taking any action for issuance of final MBA Certificate in favour of the petitioner. The copy of the said applications are attached herewith as **Annexure-3** series.

6. That, the academic session starts from September, 2016 to September, 2018 and the Session was over in the year 2018, the Opp.partis are not issuing the final certificate of MBA course in favour of the petitioner till today.



7. That, due to inaction of the Opp.parties the petitioner took the shelter of this Hon'ble Court in W.P.(C) No. 461 of 2024 which was disposed of on 16.01.2024 directing the Opp.party No.3 to consider the representation filed by the petitioner vide Annexure-3 and pass appropriate order in accordance with law within a period of three months from the date of production of

certified copy of this order. After receiving the certified copy of the order the petitioner submitted the certified copy to the Opp.party No.3 on 19.01.2024 by registered post. But the Opp.party No.3 did not complied it as per the direction of this Hon'ble Court.

8. That, thereafter the petitioner filed CONTC No. 3747 of 2024 against the Opp.party No.3/contemnor for non compliance of this Hon'ble Court's order. Notice was issued to the Opp.party No.3 /contemnor. After receiving the contempt notice from this Hon'ble Court, the Opp.party No.3/contemnor issued a letter to the petitioner on 18.06.2024 stating therein that the mark sheet of two Lab papers (MNG 208 and MMG 209) to the Director of Examination, BPUT vide his mail dated 30.08.2022 and after receiving the copy of Annexure-3 of the writ petition, the Opp.party No.3 has requested to the Vice Chancellor and Registrar, BPUT, Rourkela, Odisha through his letter No. DAMITS/4344/2024 and letter No.

Subsequently the Opp.party No.3 issued reminders to the Vice Chancellor, Registrar as well as the Director of Examination BPUT, Rourkela, Odisha vide letter No. DAMITS/4414/2024, letter No. DAMITS/4415/2024 and letter No. DAMITS/4413 of 2024 dated 30.05.2024 respectively for redressal of petitioner's grievances. 9. That, due to inaction of the Opp.party No.2 the petitioner is suffering a lot of problem in his educational life regarding issuance of MBA Certificate for the session 2016-2018 which clearly indicates the malafide intention and violates the principle of natural justice.

10. That, the non issuance of MBA Certificate in favour of the petitioner creates/hampers the educational career of the petitioner and he lost five years in his life.
