- 1. That the petitioner who was selected in the matter of contract regarding interior work of Opp. Party No.2 and letter of award was issued in its favour has been deprived to execute the agreement and commence the work. This is notwithstanding the fact that the petitioner had complied with all the required formalities and had in fact had prepared all the necessary fixed deposits and related documents within 15 days of the issuance of letter of award. The said action of the Opposite Parties more particularly the Opposite Party No.2, 3 and 4 is the subject matter of dispute in the present writ application as is arbitrary, illegal and against the principles of natural justice.
- 2. That the petitioner is a company incorporated under the Companies Act, 1956 is being represented through its Managing Director,, who is a citizen of

That pursuant to the Tender Call Notice No.RSCL/1300-2/2024 dated 23/08/2024 the petitioner had submitted his rates for "interior work of RSCL office in 2<sup>nd</sup> and 3<sup>rd</sup> floor of 1CCC building at Rourkela one on percentage rate basis". Last date of submission of the bid was 10/09/2024 and the petitioner submitted his bid within due time. Four bidders were competing in the said tender.
- 4. Bid was in two parts i.e. technical and financial bid. Technical bid was opened on 10/09/2024 and three out of four tenderers were found to be responsive. - 8. That to the utter dismay of the petitioner company, received a letter on 07/10/2024 through mail issued by the Opp. Party No.2 regarding cancellation of the Letter of Award dated 21/09/2024. - 9. That in response to the said letter the Chief Finance Officer, Opp. Party No.4 gave a reply question wise stating therein that there is no scope for grant of extension of time for signing the agreement. Copy of the letter dated 08/10/2024 is marked and annexed herewith as <u>Annexure-7</u> to this writ petition.
- 11. That the petitioner humbly submits that the Opp. Party No.2 granted four days' time for execution of the agreement in the letter vide Anenxure-2 i.e. LOA which is contrary to the provisions contained in Clause 29(2) of the DTCN vide Annexure-1 series. Clause 29(2) clearly stipulates that a bidder has to furnish performance security and additional performance security within 15 days of issue of letter of acceptance. In the present case 15 days stipulated under Clause 29(2) was to expire on 06/10/2024, if it is taken into consideration that the LOA was issued on 21/09/2024(though it was received by the petitioner on 23/09/2024 at the commencement of the business hour). Reckoning the date of issuance of letter of acceptance as 21/09/2024, 15 days expires on 06/10/2024. therefore. non-acceptance of the performance security and additional performance security presented on 05/10/2024 speaks of arbitrary exercise of power and it seems that the Opp. Parties No.2 to 4 have exceeded their jurisdiction illegally in cancelling the letter of award.

- 12. That the petitioner humbly submits that as per the clause there is 15 days and 4 days in the letter of award vide Anenxure-2 itself speaks of malafide intention of the authorities. In the circumstances, interference of this Hon'ble Court is prayed for in the matter of contract as it is public contracts where there cannot be any pick and choose in the matter. Thus has
  - reason to belief that his letter of acceptance has been rejected in order to accommodate someone else which is not permissible under law.
- 13.That in the meantime the petitioner has gathered that the Opp. Party No.2 to 4 are contemplating to issue letter of acceptance in favour of L-2 i.e. Opp. Party No.5
- 14. That, it is, therefore, expedient in the interest of justice and equity to quash the letter vide Annexure-5 and direct the Opp. Party No.2 for revival of letter of acceptance vide letter dated 21/09/2024 vide Annexure-2, failing which the petitioner would suffer irreparable loss and injuries which cannot be compensated in any way.

## PRAYER

The petitioner, therefore, prays that your Lordships shall graciously be pleased to admit this Writ petition, issue *Rule nisi* calling upon the opposite parties to show cause:

(a) As to why the letter vide **Annexure-5** shall not be quashed.



However due to delay from bank side we submitted a time extension letter on Dt.- 30.09.2024 & the end date of time extension supposed to be ends on Dt.- 06.10.2024. #### The unlawful Bidding practices are as follows:

- 1. If our time extension letter is not acceptable by you then at first you should intimate us regarding the nonacceptance of a time extension letter, instead you send a LOA cancellation letter which is quite unlawful and will be challenged in the court of law.
- 2. The copy of your office entry record book shows that we are interested for the agreement but your non acceptance shows your unwillingness towards a fair practice, which will also be challenged in the court of law.





In response to the Tender Notice, RSCL received four online bids and the following three bidders have submitted the physical copy of bids along with Earnest Money Deposit (EMD) and Tender fees in form of specified instruments :- 1. Credence Interior Pvt. Ltd. (Petitioner), 2. M/s Girish Samal (Opp. party No.6), 3.M/s. Har Har Mahadev Enterprises (Opp. Party No.5).

All three bidders were technically qualified and hence their financial NOV MA bids were opened on 19.09.2024. All the bidders quoted the same price of Rs.44,29,481.75 against estimated value of Rs.52,10,542/- i.e. (-) 14.99%. Credence Interior Pvt. Ltd. was selected as L1 bidder on the basis of the lottery. 



That the Opp. Parties have not stated the facts as there they tried to project different picture of what actually happened on 05/10/2024 when the petitioner's representative was not allowed to execute the agreement and comply with the other formalities, though the petitioner was ready and willing to comply with the provisions of section 29(2) of the bid document under the heading **Notification of award singing of agreement etc** on or before expiry of 15 days from the date of notification of the award.
- 6. That the petitioner's stand is that even if the notification of the bid is 21.09.2024 (though received in the late hours and Sunday intervened) yet 15 days prescribed in Clause 29(2) was to expire on 06/10/2024. The intention always is/was to give 15 clear days. If (21/09/2024) is excluded out of prescribed 15 days then the last date of compliance is 06/10/2024.
- 7. In any case the petitioner had gone to Opp. Parties office on 05/10/2024 but was not allowed to submit fixed deposits and execute the agreement though he was equipped with all the information/document in this regard. Copy of the required fixed deposits have already been filed in the writ petition as Annexure-4 series which are dated 03/10/2024. It is further humbly submitted that the petitioner had duly authorised the representative by way of special power of attorney executed by the

petitioner company to execute the agreement for and on its behalf and so also the work programme dated 03.10.2024. Copies of the power of attorney and the work programme are attached to the counter affidavit as **Annexure 8 Series**.

As per clause 29(2) requirements are furnish performance security and additional performance security, work programme and shall sign the agreement in the prescribed format. In compliance to the same the petitioner was ready and willing to as on 05/10/2024 but evasive reply has been filed by the Opp. Parties at paragraph 7 that the representative visited the office yet did not submit the required ISD and other documents and that he was not duly authorised to sign the agreement. The State's statement prima facie shows to be incorrect and not based on evidence.

That in reply to the averments made in unnumbered paragraph 3 under paragraph-2 to the effect that RSCL's in spite of repeated persuasion the agency did not show any interest to sign the agreement is absolutely false.

But as mentioned in Annexure 6, your office repeatedly instructed and insisted the petitioner to start the work first and to do the agreement later. The same stands unrebutted.

9. That as stated above 05/10/2024 being the last date and further allegation that on 05/10/2024 representative of the petitioner visited without any documents is absolutely false and denied.

- 10. That in reply to the averments made in paragraph-6 of the counter affidavit, it is humbly submitted that the petitioner has indicated in paragraph 6 regarding letter of award on 23/09/2024 which was sent through E-mail.
- 11. That in reply to paragraph 7 of the counter affidavit it is humbly submitted that as has been explained above the allegation that the petitioner's representative did not carry authorisation to sign the agreement is absolutely false and denied.
- 12. That in reply to the averments made at paragraph 10 of the counter affidavit it is humbly submitted that debarring/suspending/black listing a contractor from bidding is a serious consequence, therefore, it cannot be passed without proper show cause and inquiry and that having not followed the order of debarment vide Anenxure-5 is bad in law and liable to be interfered with.
- 13. That it is pertinent to mention here that on 07/10/2024 vide Annexure-5 the Opp. Parties have taken a stand that "due to non-submission ISD and APS to execute the agreement as required in LOA and Clause 29(2) by the DTCN". Letter under reference does not reflect that there was no proper authorisation on the part of the petitioner's representative to execute the agreement and that he had not submitted the work programme.
- 14. In the circumstances, conflicting stand has been taken by the Opp. Parties in the counter affidavit that Ramesh Meher, who visited the office on 05/10/2024 did not have due authorisation to sign the agreement which apparently

is not correct in view of Annexure-8 seriesa. In the follow up letter also vide Annexure-7 the only deficiency shown on the part of the petitioner is that representative only enquired about the process and documents required for signing the agreement without submitting any document. The same also contradicts as stated above in the counter affidavit. In view of whatever has been stated the alleged award of contract in favour of one Harhar Mahadev Enterprises is liable to be quashed and consequently the writ petition should be allowed.

15. That the averments which have not been expressly admitted shall be deemed to have been denied, and the Petitioner reserves his right to delete, incorporate and amend the Rejoinder affidavit as and when required or new fact or facts come to his knowledge.


