

That, the petitioner being one of the participants in the Tender proceedings has filed this instant writ petition is filed by the petitioner whereby challenging the illegal, arbitrary and unjust action finalisation of the successful bidder to the second highest bidder as per the comparative statement namely Jitendra Ku. Agrawal who has submitted the ITR of HUF and not in a personal capacity and has not submitted the details of the movable property verified from the concerned local revenue authority along with the application form which is a clear violation of the terms provided in the Tender call Notice. A Copy of the Comparative statement is annexed herewith and marked as **ANNEXURE-1**.
- 2. The Petitioner is a legal and citizen of India and falls within the jurisdiction of this Hon'ble Court. The cause of action for filing of the present writ petition, the details whereof submitted in the succeeding paragraphs, has also arisen within the territorial jurisdiction of this Hon'ble Court.
- 3. That the Tahsildar, Jharbandh has issued a Tender Call notice for lease of the term 2022-23 to 2026-27 of sand Quarry, Jagdalpur along with two other sand Quarry. The last date for filing of Tender is 25.08.2022. As per Tender call notice the minimum price per cubic metre as govt price is fixed of Rs.750/- (Rupees Seven Fifty only) excluding other charges. A Copy of Tender Call Notice dtd.1.08.2022 is annexed herewith and marked as ANNEXURE-2.
- 4. That in respect of Jagdalpur Sand Quarry altogether eight persons participated in the Tender and the authorities on 21.09.2022 has finally Opened the Tender in the presence

The Tender committee and thereafter prepared a bid sheet which has signed by all the tendering authorities. A Copy of the Tender Call bid sheet dtd.21.09.2022 is already annexed herewith as Annexure-1 to this writ petition.

- 5. That as a matter of fact as per Tender bid sheet dtd.21.09.2022 one Sacchin Agrawal has quoted the Highest price of Rs.1857.02/- (Rupees Eighteen Hundred Fifty-Seven rupees only) but the authority concerned reason best known to them did not issued intimation to Sacchin Agrawal aland waited one year after opening of the tender and recently issued a letter dtd.13.10.2023 to all the participants to select successful bidder and now decided second highest bidder namely Jitendra Ku. Agrawal who has quoted approximately less of Rs.450/- (Rupees Four Hundred Fifty only) from the highest bidder though he has not submitted the IT return for the tender documents in his personal capacity rather submitted IT return under HUF. The said letter mentioned the delay of selection due to pending of various Writ petition before the Hon'ble High court of Orissa.
- 6. That when the matter stood thus suddenly the Tahsildar issued a Letter on dtd.13.10.2023 to the present petitioner along with other participants regarding finalisation of successful bidder in respect of Jagdalpur Sand Quarry wherein all the participants are requested to remain present on 31.10.2023 at about 10 A.M. A Copy of the letter dtd.13.10.2023 is annexed herewith and marked as <u>ANNEXURE-3</u>.

- 7. That in the aforementioned letter contents the bidder was not finalised because there is direction of Advocate General, Odisha Cuttack vide Lett No.49220(3) dtd.20.09.2022 till disposal of the writ application (Mentioned in the Letter) pending before this Hon'ble High court of Orissa and to implement the order of this Hon'ble High court of Orissa to select the successful bidder accordingly this latter is issued by the Tahsildar.
- 8. That the petitioner thereafter verifies the orders the writ application mentioned in the letter and found that there is no interim order to finalise the successful bidder and this Hon'ble court of Orissa only disposed of the writ application as the matter has been infructuous and some of the matter has been withdrawn. - 10. That the tahsildar after delay of 1 year instead of going for a fresh tender Notice with an ulterior motive selected the second Highest bidder namely Jitendra Ku. Agrawal who has quoted the price of Rs.1405 per Cubic Meter which is less of Rs.450 (Rupees Four Hundred Fifty Only) from the highest bidder who has quoted the price as Rs.1857.02 (Rupees Eighteen Hundred Fifty-Seven Only) which cause huge loss to the state exchequer.
- 11. That at the time of finalisation of successful bidder by the tendering committee they have selected Jitendra Ku. Agrawal as the successful bidder who is the second highest bidder as per the tender Comparative Statement and when the Opposite parties are trying to declare in presence of the petitioner along with other participants the petitioner immediately object to such selection as because he has not submitted the ITR for the year 2021-2022 on his personal capacity but submitted the ITR of HUF which is not permissible under the OMMC Rule,2016. Thereafter the Tahsildar intimated the petitioner that he will refer the matter to their Higher Authorities to get approval for issuance of intimation to the second highest bidder as successful bidder.
- 12. That it is humbly submitted that the ITR of HUF will not be accepted as because when the rule is enacted the intention of the rule makers is that any amount defaulted by the lease holder during the lease period will be realised through certificate proceeding but in respect of the HUF ITR the state government cannot recovered their dues from the member of the HUF.

- 13. That in the aforementioned Circumstances if the second highest bidder Jitendra Ku. Agrawal bid amount is not accepted on the ground for submission of the ITR of HUF then the present petitioner is the Second highest bidder and entitled to be declared as a successful bidder.
- 14. That as per Tender call notice Vide Annexure -2 is mandatory every applicant has to submit their movable property after getting approval from the concerned Local revenue authority but in the present case the second highest bidder has not submitted his movable property. Hence, the said offer may not accepted in the eyes of Law and the authority should go for a next highest bidder.
- 15. That it is pertinent to mention here that pursuant to the tender call notice the tender was opened in due time but the Tahsildar didn't finalised the highest bidder from last one year though there is no specific order from the Hon'ble Court to stay the further proceedings in the tender call Notice only after disposal of the writ application the Tahsildar reason best known to him now going to issue intimation to Jitendra Ku Agrawal who has not participated in his individual capacity by filing the ITR of year 2021-22 on the basis of the HUF which is not in accordance with the terms of the OMMC Rule,2016.
- 16. That the Tahsildar instead of going for a fresh tender now settle the lease with the second highest bidder which is illegal and entire tender process has to be set aside as none of the participants filed their property details pursuant to condition No.4 of the Tender Notice.

- 17. That, it is humbly submitted that the petitioner urges before this Hon'ble Court to grant her leave to plead additional grounds if any at the time of hearing.
- **18.** That the Petitioners having no other speedy or efficacious remedy has moved before this Hon'ble High Court.
- 19. That, if the prayer made hereunder is not granted then the petitioner will be highly prejudiced and will suffer irreparable loss.

In the light of the aforesaid facts and circumstances this Hon'ble Court may be graciously pleased to set aside the selection of the Opp. Part No.5 as successful bidder by cancelling the entire Tender call Notice vide Annexure -2;

And; Further be pleased to direct the Opp. Party authority to conduct a fresh tender in respect of Jharband Sand Quarry.

And; be further pleased to pass any other order(s)/Direction(s) as this Hon'ble Court thinks fit and proper;

And; for this act of kindness the petitioner as in duty bound shall every pray.







No.8 have been disqualified namely Nilamani Dansana and Krutibas Pradhan because no amount has been quoted and quoted the amount as "NIL". A Copy of the checklist for verification of Documents in the Jagadalpur Sand Querry auction dated 21.09.2022 is already annexed as Annexure-1 in the writ petition and again being annexed here for adjudication of this matter as ANNEXURE-B/1.
