


- 1. That, in this Writ Petition, the Petitioner prays for direction for cancellation of the application /tender/bid of Opp. Party No-6 in respect to Balangir Sand Quarry under Jharbandh Tahasil in the District of Bargarh, since they are not eligible to participate in the Tender for lease of the Jagadalpur Sand Quarry, under Jharbandh Tahasil in the District of Bargarh.
- 2. That, the Opp.Party No-5 vide advertisement No-1491 dated 1-8-2022 invited Application /Tender/Bid from the interested candidates to lease out 3 Sand Quarry i.e the Jagadalpur Sand Quarry ,Lergoan Sand Quarry and Balangir Sand Quarry on the criteria of eligibility mention therein. In this respect the true copy of the advertisement No-1491 dated 1-8-2022 has been annexed along with this writ petition and marked as ANNEXURE-1.



3. That, on 13-10-2023, when the petitioner knew that the bid of Opp. Party No-6, who has no eligibility to participate in the Tender as per the advertisement vide Annexure -1, have been called to participate in the finalisation of Tender, the petitioner immediately orally objected before the Opp.Part No-5 i.e Tahsildar Jharbandh on the ground that Opp.Party No-6 has no financial viability as an individual to participate in the Tender Process. In this respect the true copy of the letter of Tahsildar dated 13-10-2023 has been annexed along with this writ petition and marked as <u>ANNEXURE-2.</u>

4. That the Opposite party No.6 has applied to participate in the Bid for Jagadalpur Sand Quarry by producing the Income Tax Return of the Hindu Undivided Family(HUF).

5. That, the petitioner most humbly submits that, the application to participate in the tender has been invited from the interested person and not from the Hindu Undivided Family (HUF). In this respect it is humbly submitted that the applicant is in person i.e. Jitendera Kumar Agrawal but Income Tax Return of the Hindu Undivided Family (HUF). Hence the Application /Tender/Bid of Opp. Party No-6 should be cancel since he has no personal Income Tax Return. In this respect it is further submitted that if the applicant is in person,





then the Income Tax Return should also be personal. But the Opp. Party No-6 with a purpose to defraud the Tahsildar has given the Income Tax Return of the Hindu Undivided Family (HUF), which should not be accepted.

- 6. That the same question did arise at the time of finalisation of successful bidder in respect to Jagdalpur sand quarry by the same Tahsildar namely Jharbandh.
- 7. That Opp.Party No- 6 is required to be declared disqualified to participate in the Tender. Opp. Party No.6 does not have the appropriate Income Tax Return.

8. That as soon as it come to the knowledge of the petitioner regarding disqualification of Opp.Party No-6, he immediately file one representation before Opp. Party No-5 Tahsildar, Jharbandh for inquiry and deletion of their name from the name of bidder vide representation dated 02-11-2023 which was duly received by Opp. Party No-5 Tahsildar, Jharbandh but even in the meantime many days have been passed ,no action has been taken by the Opp. Party No-5, regarding cancellation of tender of Opp. Party No-6. In this respect the true copy of the dated 02-11-2023 has been annexed along with this writ petition and marked as ANNEXURE-3.



- 9. That it come to the knowledge of petitioner that Opp.Party No-5 in connivance with Opp.Party No-6 is going to finalised the tender even if he has no eligibility.
- 10. That such inaction of the Opposite parties is arbitrary and illegal and needs interference of this Hon'ble high court for the interest of justice.
- 11. That in case a direction is not given to Opp. Party No- 5 to cancel the tender of Opp. Party No- 6 and thereby call other tenderer, then great prejudice will be caused to the Petitioner which cannot be compensated in any other term.







- 2. Heard Mr. A. Mishra, learned counsel appearing for the petitioner and Mr. P.P. Mohanty, learned Additional Government Advocate appearing for the State-opposite parties.
- 3. Mr. A. Mishra, learned counsel appearing for the petitioner contended that Annexure-1 is the check list for verification of documents for five years long term lease of sairat sources, namely, Jagadalpur Sand Quarry, for which auction was held on 21.09.2022, wherein the name of opposite party no.5 finds place at Sl. No.3. From the same it would be evident that opposite party no.5 has quoted Rs.1405/- towards additional charges, whereas the petitioner has quoted Rs.1278.13. So far as opposite party no.5 is concerned, he has furnished the bank guarantee/ITR filed for the year 2021-22 for individual but not for HUF, but it has been stated as HUF. If he submitted ITR for the year 2021-22 for

individual business, the same cannot be in conformity with the provisions of law. Thereby, his bid should not have been accepted by the opposite party-authorities.




