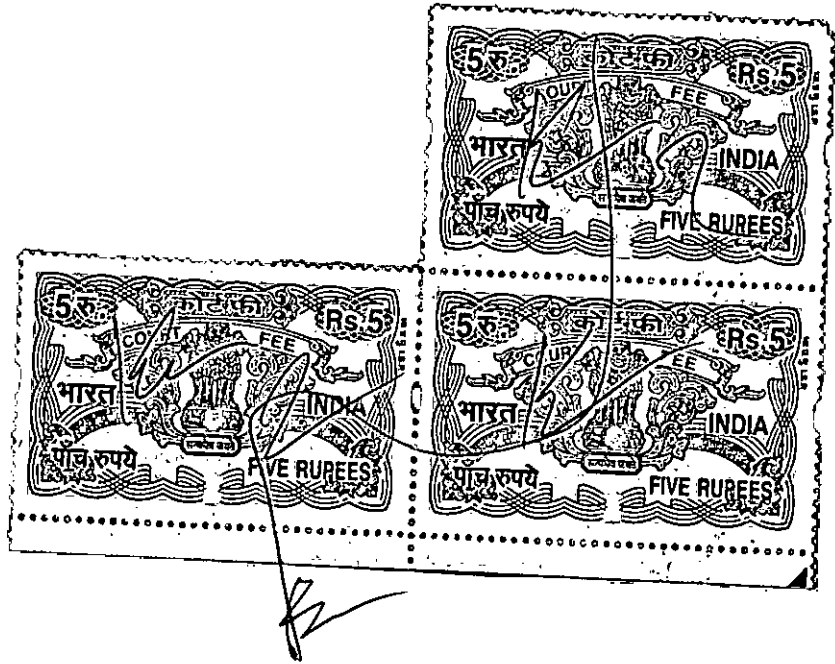

GROUND OF APPEAL

1. That the instant appeal is preferred against the order dated 09.11.2023 passed by court of learned Additional Sessions Judge, Amritsar in case bearing FIR no.0025 dated 13.08.2023, Under Section 13, 17, 18, 20 of The Unlawful Activities (Prevention) Act, 1967 (Amended 2012), section 25 of Arms Act, 1959 and sections 109, 115, 120-B of IPC, 1860, registered at Police Station State Special Operations Cell, Amritsar, District Intelligence Wing (CID) (Annexure P-1) whereby the bail application bearing No.BA-CIS 6810 of 2023 filed under section 438 Cr.P.C. for grant of anticipatory bail has been dismissed which is illegal, arbitrary, against the facts on record hence liable to be set aside by this Hon'ble Court. The true translated copy of FIR is annexed herewith as **Annexure A-1.**
2. That the Appellant has been falsely implicated in the abovementioned case on motivated considerations. The FIR has been lodged on the basis of secret information against the present appellant and others wrongly.
3. That the brief facts of the case are that the present case has been registered against the Appellant on the basis of secret information received by DSP Harwinderpal Singh against the present Appellant and others on the allegations that the accused in the FIR are in touch with terrorists and are planning to disturb peace and harmony of the State. As per secret information all the accused named in the FIR had made a group and are planning to commit some big terrorist activities. The present FIR has been registered on the basis of secret information received by DSP Harwinderpal Singh.

4. That the present FIR has been lodged on the basis of secret information against the Appellant and co-accused. The Appellant is totally innocent and has not committed any offence.
5. That nothing is to be recovered from the appellant and the appellant is ready to join the investigation and undertake to abide by the terms and conditions as imposed by the Hon'ble Court and they are giving undertaking to appear before the Trial Court on each and every date.
6. That as per the version of the FIR, no recovery has been effected from the Appellant. Appellant has been falsely implicated in the present case. Appellant is totally innocent person.
7. That no useful purpose will be served by sending the Appellant behind bars. Moreover, no custodial interrogation is required.
8. That the ingredients of offence as mentioned in the FIR are not made against the present Appellant.
9. That the present Appellant is a law abiding citizen and has never indulged in any criminal activity.
10. That, the ld. Lower court did not apply its judicious mind while declining the prayer of anticipatory bail to the Appellant vide order dated 09.11.2023 and gave no cogent reasons thereof.
11. That the Appellant undertake to abide by all the conditions laid down by this Hon'ble Court and will not tamper with the complainant's evidence.
12. That Appellant is not involved in any other case or FIR registered/ pending against him anywhere in India.
13. That the Appellant have not filed any other such or similar appeal either in this Hon'ble Court or in the Hon'ble Supreme Court of India. No such appeal is pending in the court of Sessions or in any other competent court of law at the time of filing of this appeal.

It is, therefore, respectfully prayed that the present appeal may kindly be allowed and the impugned order dated 09.11.2023 passed by Ld. Additional Sessions Judge, Amritsar passed in FIR no.0025 dated 13.08.2023, Under Section 13, 17, 18, 20 of The Unlawful Activities (Prevention) Act, 1967 (Amended 2012), section 25 of Arms Act, 1959 and sections 109, 115, 120-B of IPC, 1860, registered at Police Station State Special Operations Cell, Amritsar, District Intelligence Wing (CID) (Annexure P-1), whereby the bail application bearing No.BA-6810 of 2023 filed under section 438 Cr.P.C. for grant of anticipatory bail has been dismissed, may kindly be set-aside and appellant may kindly be granted the concession of anticipatory bail, in the interest of justice.

It is further prayed that the arrest of the Appellant may kindly stayed during the pendency of the petition, in the interest of justice.

It is further prayed that Appellant may kindly be exempted from filing the certified/ typed copies of impugned order dated 09.11.2023 and Annexure P-1, however, photo copies and translated copies of the same are attached herewith.

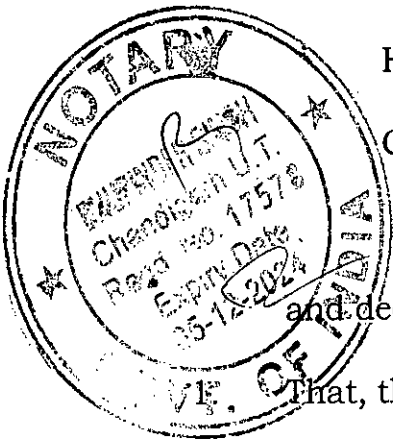

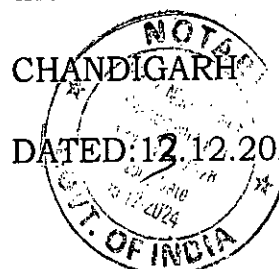

ORDER

1. Present bail application has been moved on behalf of
the accused-applicant for bail under Section 438 of Criminal
Procedure Code in FIR No. 25 dated 13.08.2023 under section 25
of Arms Act and 13, 17, 18 and 20 Unlawful Activities Prevention)
Act, 1967 and 109, 115 and 120-B of Indian Penal Code registered
at Police Station SSOC, Amritsar.
2. Notice of the bail application was issued to the
prosecution and Ms. Anju Sharma, Addl. PP for the State has
appeared on behalf of State.

3. I have heard arguments of the learned counsel for the accused-applicant and the learned Addl. P.P. for the State.

4. The learned counsel for the accused-applicant contended that the accused-applicant is innocent and has been falsely implicated in the present case. Nothing is to be recovered from applicant-accused. He is ready to join the investigation as and when required by the police. He lastly prayed that the accused-applicant may kindly be released on bail.

5. On the other hand, learned Additional P.P. for State strongly opposed the bail application and prayer for dismissal of the same.

6. Having heard both sides, I have gone through the record. Perusal of the file reveals that present case has been registered against the accused-applicant on the basis of secret information received by DSP Harwinderpal Singh regarding the anti-national activities of Harpreet Singh alias Happy son of Gurwinderpal Singh, resident of Passiya Ramdass, Amritsar, who is currently based in America and is in touch with notorious terrorist Goldy Brar, wanted in many criminal cases. Both are planning to execute a terrorist activity in India on the behest of a Pakistan based terrorist Harwinder Singh Rinda, chief of banned terrorist organization Babbar Khalsa International. They are planning to target political and religious leaders to disturb peace and harmony of the State. Both Goldy Brar and Harwinder Singh @ Rinda have been designated as terrorists by the Indian Government. Above

Happy is having good hold in nearby the areas of Batala, Gurdaspur and Ajnala, Amritsar and in these areas, he has recruited his associates namely Gurbinder Singh alias Lahoria, resident of Bohlian, Ajnala, Amritsar, Sukhmanpreet Singh alias Jeevan, resident of Ajnala, Amritsar, Gurinder Singh, resident of Ajnala, Amritsar, Kamaljit Singh @ Kamal, resident of Ajnala, Amritsar, Narinder Singh, resident of Urdan, Amritsar, Lovepreet Singh, resident of Urdan, Amritsar and other members in to terrorist folds. Harpreet Singh alias Happy had arranged a consignment of arms ammunition from Pakistan through above Harwinder Singh alias Rinda and the same was forwarded to the above-named associates. Happy has also arranged funds through different channels for his associates in preparation for a terror strikes in Punjab and Delhi.

7. Perusal of the file reveals that there is serious and specific allegations against the accused-applicant. So, keeping in view the above facts and circumstances of the case, this court is of the considered view that accused-applicant does not deserve for concession of anticipatory bail. Hence, bail application filed by applicant-accused is hereby dismissed. File of the bail application be attached with remand papers.

Secret informer told that happy above said is having links in Ajnala, Batala, Gurdaspur and nearby places, and in this area, he along with his companions, Gurbinder Singh alias Lahoria, resident of Bohlia, Ajnala, Amritsar, Sukhmanpreet Singh, alias Jeevan, resident of Ajnala, Amritsar, Gurinder Singh, resident of Ajnala, Amritsar, Kamaljit Singh alias Kamal, resident of Ajnala, Amritsar, Narinder Singh, resident of Urdan, Amritsar, Lovepreet Singh, resident of Urdan, Amritsar have made a group along with

other companions. In last days Harpreet Singh Happy above said with the help of his companion members and with the help of Harvinder Singh have got weapons through Indo- Pak border and is sending money through various channels to this group. On the instructions of Happy, his companions were trying to commit some big terrorist activity in Punjab and Delhi. Secret informer told that the companions of Happy above said or gathering to commit some big activity in Ranjit Avenue, B-Block market. If the operation with planned manner is conducted, so the above said can be arrested with illegal weapons and they will be stopped from committing any big activity. The above information is solid and in this regard ruqa under section 13, 17, 18, 20 UA (P) Act, 25 of Arms Act, 109, 115, 120-B of IPC is send to register the FIR by hand through C-2 Bikramjit Singh no.1/623. After registering the FIR, number be informed and special reports be send to Illaqa Magistrate and officers. Control room be informed through telephone, wireless to make arrest of the accused, effective teams are made under the supervision of Inspector Sukhbir Singh and Harbhej Singh. I DSP, alongwith other companions is going to the spot.
